Created in 1930 as the Hamilton County Park District, Great Parks of Hamilton County now boasts 21 parks and preserves, spanning more than 17,000 acres of green-space across Hamilton County, Ohio. Visit their website at www.greatparks.org.



Todd Palmeto, is the Chief of Planning for the Great Parks of Hamilton County. Going on his 15th year with the organization, Mr. Palmeto has been in this most recent role since July 2017 after serving in other roles at the park district.

Mr. Palmeto, with a team of 29 full-time professionals and technical experts, leads planning, marketing and public engagement, IT and data management, design and land acquisition, facilities and infrastructure, and grant writing.

Todd manages the implementation of park district sustainability initiatives, collaborates with Chief of Conservation and Parks to incorporate the best ecological practices and policies to reduce environmental impacts, and led the completion of the 2017 update to the comprehensive master plan.
