H.B. 62 was signed into law April 3rd, 2019 by Governor Mike DeWine Bill gives ODOT an additional \$450 million annually. Bill gives Local Governments around Ohio over \$370 million annually Cities receive a 62.5% increase in MFT, Townships receive a 67% increase Every County Engineers receives a \$1.53 million increase from MFT (62.8%)






OHIO ROAD/HIGHWAY FATALITIES 1936-2019






